- Applied for enrollment (admission) in an institution of higher education within 24 months after high school graduation, **and**
- Submitted a final, official transcript issued by a Florida public or private high school as evidence of attendance and graduation, **and**
- Submitted proof of application for admission to an institution of higher education within 24 months of graduation from high school if that institution was not Santa Fe College.

IMPORTANT:

- This waiver covers up to 110 percent of the student’s program requirements. Credits over 110 percent will be charged at the out-of-state rate of tuition.
- Request for waiver must be submitted by to the first day of class of the term for which you are requesting the waiver of fees.
